TERMS AND CONDITIONS

PRICES

- **General price - EUR 5,950**
- **Early Bird price - EUR 5,700 (for fees paid in full by July 26, 2025)**

***Rates are per person based on double occupancy.** For single rooms, there will be a **supplemental fee of EUR 1300.**

Note: Single rooms are limited. We can assist with pairing up individual travelers in twin rooms.

TOUR PRICE INCLUDES:

- Accommodation in 4–5-star boutique hotels with breakfast every morning.
- Airfare between Barcelona and Granada, including checked luggage up to 25 kg and complimentary underseat cabin bag with a maximum dimension of 40x30x20 cm and 10 kg.
- High-Speed Train in Business Class from Seville to Madrid.
- Touring in comfortable, air-conditioned private coach bus.
- 6 group meals, including Sabbath dinner (water and wine included at meals, vegetarian options by request, certified kosher is not available).
- Entrance fees as specified in the itinerary.
- Flamenco performance in Seville.
- Experienced, licensed English speaking tour guides.
- **Moisés Hassán Amsélem** or a partner from **Jewish Spain Tour** will accompany the group from arrival until departure along with a **Learn-in-trips** tour group leader.

PRICE DOES NOT INCLUDE:

- Airfare to and from Spain.
- Ground transportation to and from airports on arrival and departure.
- Travel & Health Insurance: All participants should be aware that while all efforts are made to avoid any problems before, during or after the trip, **Nora Kaplan Ltd.** DOES NOT carry any insurance for health or luggage of the

participants. While using the services only of registered suppliers, we recommend that you purchase fully comprehensive travel insurance that includes cancellation for any reason (including COVID19) as **Nora Kaplan Ltd.** cannot be held liable for any mishaps during participants stay.

- Additional luggage and/or carry-on baggage exceeding the airline's allowance will incur an extra cost for the participant. It is recommended to purchase this in advance, and assistance in purchasing this in advance can be provided upon request.
- Entrance fee to optional attractions during free time.
- Personal extras such as laundry, or beverages and food other than the included in the program's breakfasts and group meals.
- Tips for local service providers (guides, drivers, portering...): EUR 10/person/day to be collected in cash at the beginning of the trip (EUR 100/person for the entire tour).
- Miscellaneous expenses such as departure fees, visas, and security surcharges, where applicable.

PAYMENTS:

- A **non-refundable deposit of EUR 500 per person** is required at the time of booking to confirm your reservation.
- The **full tour fee is EUR 5,700** (including the EUR 500 non-refundable deposit) if paid **before July 26, 2025**.
- After July 26, the **full tour fee is EUR 5,950** (including the EUR 500 non-refundable deposit) and can be paid at the time of booking.

For installment payments of the Main Tour:

1. **EUR 3,225** must be paid at the time of booking (including the EUR 500 non-refundable deposit).
 2. **EUR 2,725** must be paid by **September 3**. If the first payment of EUR 3,225 has not been made yet, both payments must be completed by this date.
- The **single supplement fee of EUR 1300** must also be paid by **September 3**.

***A minimum of 15 participants are required to run the tour. For a group of 11-14 participants there will be an increase of EUR 100 to be paid by October 26, 2025.**

- Tips for local service providers (guides, drivers, portering...): EUR 10/person/day to be collected in cash at the beginning of the trip (EUR 100/person for the entire tour).

- Credit card information and certain personal details will be required at the hotel check-in as a guarantee for any incidental or damage, and in compliance with local regulations.

CANCELATION FEES

- The deposit of EUR 500 is non-refundable.
- For cancellations made more than 45 days before the start of the main trip, a full refund will be issued, minus the non-refundable deposit.
- If canceled between 45 and 15 days before the start of the tour, a 50% penalty will apply, in addition to the non-refundable deposit.
- For cancellations made less than 15 days before the tour start date, a 100% penalty will apply.

RESPONSIBILITY:

Initial registration indicates agreement with all terms and conditions as stated in this document.

- This trip is organized and executed by **Jewish Spain Tour**, with **Nora Kaplan Ltd.** acting as its agent and promoter.
- **Nora Kaplan Ltd.** and **Jewish Spain Tour** reserve the right to make any itinerary changes whenever, in its sole judgement, as conditions warrant.
- **Nora Kaplan Ltd.** and **Jewish Spain Tour** shall not be liable, directly or indirectly, for any injury, death or damage for any reason whatsoever, including but not limited to war, acts of God, weather, strike, detention, delay, airline or other travel-related circumstances.
