PRICES

Main Tour:

- **General price - EUR 3,699**

*Rates are per person based on double occupancy. For single rooms, there will be a supplemental fee of EUR 650.

Note: Single rooms are limited. We can assist with pairing up individual travelers in twin rooms.

Optional Barcelona Extension:

- **General price - EUR 1,299**

*Rates are per person based on double occupancy. For single rooms, there will be a supplemental fee of EUR 300.

Note: Single rooms are limited. We can assist with pairing up individual travelers in twin rooms.

TERMS AND CONDITIONS

PAYMENTS:

- A **deposit of EUR 500/person (non-refundable)** must be received at the time of booking in order to confirm your reservation.
- **Full fees of the Main Tour (EUR 3,699)** can be paid by the time of booking (the EUR 500 non-refundable deposit are included).
- For instalment payments of the Main Tour:
 1. **EUR 2,350** must be paid the time of booking (the EUR 500 non-refundable deposit are included).
 2. **EUR 1,349** must be paid by September 15 (+ the EUR 2,350 first payment if they haven't been paid yet).
- For **Barcelona Extension, the full fees (EUR 1,299)** must be paid by the time of booking.
- The single supplements for the Main Tour and the Barcelona Extension must be paid by September 15 if applicable.

***A minimum of 15 participants are required to run the Barcelona Extension. For a group of 11-14 participants there will be an increase of EUR 150 to be paid by September 15.**

- Tips for local service providers (guides, drivers, portage...): EUR 10/person/day to be collected in cash at the beginning of the trip (EUR 80/person for Main Tour plus EUR 30 for Barcelona Extension).
- Credit card information of the participants will be required when checking in at the hotels as a guarantee in case of hotel incidentals or damage.

CANCELLATION FEES

- Deposit (EUR 500) Non-refundable.
- 25% of General prices (Main Tour and Barcelona Extension if applicable) penalty applies if cancelled between 90-45 days before the Main Trip is scheduled to start.
- 50% of General prices (Main Tour and Barcelona Extension if applicable) penalty applies if cancelled between 45-15 days before the Main Trip is scheduled to start.
- 100% penalty applies if cancelled less than 15 days before the trip is scheduled to start.
